


- I. Ensure all parts have been removed from the carton and place on a protected surface or carpet.
 - 2. Check all parts and hardware are the same as the "Parts List".
 - 3. Connect Seat Frame (2) to Back Frame (1) with Bolts (A), Flat Washers (C) through frame with Flat Washer (C), Lock Washer (E) & Nut (E).
 - 4. Tighten with Allen Key (F) & Wrench (G).




1. Connect Right Arm (4) & Left Arm (3) to Back Frame (1) with Bolts (B), Flat Washers (C).


Then tighten with Allen Key (F).




- I.Connect Right Arm (4) & Left Arm (3) to Seat Frame (2) with Bolts (A), Flat Washers (C) through frame with Flat Washer (C), Lock Washer (D) & Nut (E).
 - 2. Tighten with Allen Key (F) & Wrench (G).




Attached Base Frame (5) to the assembly unit.




- I. Connected to the side of Base Frame (5) to Arm (3) & (4) with Bolts (B), Flat Washers (C) through tube of Seat Frame (2) with Flat Washer (C), Lock Washer (D) & Nut (E).
 - 2. Then tighten with Allen Key (F) & Wrench(G).
 - 3. Connected the central rail of Base Frame (5) to Seat Frame (2) with Bolts (B), Flat Washers (C) through frame of Seat Frame (2) with Flat Washer (C), Lock Washer (D) & Nut (E).
 - 4. Tighten with Allen Key (F) & Wrench (G).




- **6.** I. Attach Stool Base (7) to Stool Seat Frame (6).
 - 2. Connected with Bolts (A), Flat Washers (C) through frame with Flat Washer (C), Lock Washer (D) & Nut (E).
 - 3. Tighten with Allen Key (F) & Wrench (G).




- 1. Open the vacuum packed Seat Cushions (8) x 2 by carefully cutting the bags with a pair of scissors. Insert the Seat Cushions (6) into the appropriate Left Seat Covers (10) & Right Seat Cover (12). Remember to keep the top side of the Seat Cushions (8) with the top side of the Seat Covers (10) & (12).
 - 2. Open the vacuum packed Seat Cushions (9) by carefully cutting the bags with a pair of scissors. Insert the Seat Cushions (9) into the appropriate Seat Covers (11).
 - 3. Open the vacuum packed Stool Seat Cushions (15) by carefully cutting the bags with a pair of scissors. Insert the Stool Seat Cushions (15) into the appropriate Stool Seat Covers (16).



- **8.** I. Attach Traction Sheet (17) on top of Seat Frame (6).
 - 2. Put Stool Cushion (16) on Traction Sheet (17).




- 1. Fluff all cushions and pillows to allow them to expand. Seat and back cushions may take 24-48 hours to fully expand, which will allow wrinkles and indentations caused by packing to fade.
 - 2. Lastly, position all cushions (10), (11), (12), (13), (16) and Pillows (14) on the sofa.



Periodically (every 90 days) make sure that the bolts are still fully tightened. **ATTENTION**: Be certain that all bolts are fully tightened before using sofa.

Limited Warranty

The manufacturers products are warrantied against defects in material and workmanship while owned by the "Original Purchaser". The term "Original Purchaser" is defined as the party or entity which purchases this manufacturer's furniture from an authorized retailer as shown by the original sales receipt. This warranty does not apply to "as is" or previously owned products.

The manufacturer warrants its products to be free from defects in materials and workmanship (normal wear and tear, fading and stretching excepted), for one year from the date of purchase, except as provided below under the limited warranty. The exceptions or exclusions to this warranty are as follows:

- I. Any warranty claim that is submitted after the limited warranty period, or without proper proof of purchase will not include the cost of parts, labor, or delivery.
- 2. This warranty shall not apply to the manufacturer's products which have been subjected to misuse, neglect, alteration, modification, or attachments, either caused by the Original Purchaser, shipping, storage, accident, fire, flood, or acts of God.

In the event of a defect in material or workmanship covered by this warranty, the manufacturer will repair or replace, at their discretion, without charge the warrantied parts within a reasonable amount of time. We reserve the right to require damaged parts to be returned to us upon request. Natural markings such as scars, brands, grain variations, wrinkles, color variations, etc. will be considered normal characteristics and not construed as defects.
