### WARNINGS

- 1. Bins and rails may fall off and cause potential injury if not mounted properly. Ensure rails are mounted to load bearing studs or surface. Please contact local professional contractor if unsure of the condition of the mounting surface.
- 2. Failure to use proper mounting hardware can cause potential injury. Mounting hardware not included. Each section of the rail must be secured by (2) fasteners. Use proper mounting hardware (screws and necessary anchors) for the type of surface intended. Please contact local professional if unsure of hardware needed.
- **3.** Do NOT modify the product in any way. Unauthorized modification may impair the function and/or safety of the product, and may affect the life of the product.
- 4. Check for damaged parts. Replace damaged or worn parts, and never use this product with a damaged part.
- **5. Bins may fall off if not hung on the rail properly.** Ensure back of the bin is fully hooked onto the rail before letting go.
- 6. Do NOT overload the product.

- Carefully check that the bins will safely hold the intended parts.
- Keep the bins dry, clean, and free from oil and grease.

### **1 YEAR LIMITED WARRANTY**

#### **Bin Pack**

We warrant to the original consumer purchaser ("Purchaser") of this Bin Pack ("Product") that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Our obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of us, during the warranty period. All replaced parts and Products become the property of us and must be returned to us.
