


- Do not stand, jump on this chair.


- Ne pas se mettre debout ni sauter sur ce siège.

- 1) Fasten (part D,C) to (part A) using screw (d) washers (e,f) and allen wrench (g).
- 2) Move the back support (part A) from flattened to vertical position as shown in the pics.
- 3) Push down on the back support to lock it firmly in place.

- 1) Sujete (parte D, C) a (parte A) utilizando tornillos (d) arandelas (e, f) y una llave Allen (g).
- 2) Mueva el respaldo (parte A) de la posición aplanada a la vertical como se muestra en las fotos.
- 3) Empuje hacia abajo el respaldo para bloquearlo firmemente en su lugar.

- 1) Fixez les pièces D et C à la pièce A à l'aide de la vis (d) des rondelles (e, f) et de la clé Allen (g).
- 2) Déplacez le support arrière (partie A) de la position aplatie à la verticale, comme indiqué sur les illustrations.
- 3) Appuyez sur le support arrière pour le verrouiller correctement à sa place.



- 4) Use the clevis and cotter pins (parts a,b) to fasten the back support of the base.
- 5) With (part B) unzipped, wear over the back structure on A. Then Zip-down.
- 6) Fasten the hook and loop.

- 4) Use la horquilla y los pasadores (partes a, b) para sujetar el soporte posterior de la base.
- 5) Con (parte B) con la cremallera abierta, use sobre la estructura posterior en A.  
Luego, cierre con cremallera.
- 6) Abroche el gancho y el bucle.

- 4) Utilisez la manille et les goupilles fendues (pièces a, b) pour fixer le support arrière de la base.
- 5) Laissez la partie B ouverte et enflez sur la structure du dossier en A puis refermez la fermeture éclair.
- 6) Fixez le crochet et la boucle.
